3. All photo reproduction orders must be PRE-PAID in accordance with the current fee schedule before the image is sent for reproduction.
4. All negatives and color transparencies remain the property of the Chapman Historical Museum. If lost or damaged, loaned items will be reproduced at borrower's expense. Replacement may require new photography.
5. The Chapman Historical Museum will receive one complimentary copy of the publication/film/video in which its image(s) appear.
6. Each image must be reproduced unaltered and in its entirety unless approved in advance, in writing, by the Chapman Historical Museum. When a detail is used, the word "DETAIL" must appear in the credit line.
7. Same page credit line, reading "*Courtesy of The Chapman Historical Museum*" must accompany each image in printed format, including publicity and advertising material. Digital images will be watermarked "*Chapman Historical Museum*".
8. For film, video and slide presentations, the Chapman Historical Museum must be acknowledged at some point in the presentation.
9. For exhibition and display, the label must carry the credit line of the Chapman Historical Museum. Additional photographer's or artist's credit may be required.
10. For website use, digital images will be reproduced at 72 dpi or less. These images and captions will be hot-linked to the Chapman Historical Museum website, www.chapmanmuseum.org
11. Permission to publish is for one-time use only. Any subsequent use must be requested in writing and will be subject to current use fees.
12. Permission is valid only for the individual, company, or institution to whom it is specifically issued and may not be transferred, assigned, sold, or otherwise disposed of without written permission of the Chapman Historical Museum.
13. The Chapman Historical Museum assumes no responsibility for any royalties or fees claimed by the artist or photographer, or on his/her behalf.
14. In the case where copyright is held by a third party, written permission must be secured by the applicant from that party or their agent, and must accompany the application.
